**I. Call to Order**

Ms. Comperchio made a motion to appoint Mr. Huntress as Chair of the CSC for the 2022-2023 year. Ms. Wilson seconded the motion.

There was discussion regarding the value of continuity on committees and subcommittees.

Ms. Patel made a motion to appoint Ms. Wilson and Ms. Whitt to the Concord-Carlisle Regional School Committee for the 2022-2023 year. Ms. Comperchio seconded the motion.

Appointments to the CSC Subcommittees and committee liaison positions will be made at a later date. These appointments do not require a committee vote. It was suggested to collect a description of each role and estimated time commitment to share with committee members.

It was noted that MASC will be hosting a session of "Charting the Course" for School Committee members in Bedford in June. The next School Committee meeting is scheduled for June 1<sup>st</sup> and items on the agenda will include the superintendent's evaluation and the possible installation of security cameras in the district.
