COMMON VICTUALLER'S LICENSE PROCEDURE

INSTRUCTIONS:

It will be necessary for the Applicant to comply with the following:

1. Applicant must file a Common Victualler's License Application with the appropriate fee (\$25.00).
2. Applicant must obtain approval from the Building Inspector and the Board of Health. (See attached form)
3. Applicant must submit a Building Floor Plan showing all seating, bar or lounge area (if applicable), entrances, exits, loading dock or receiving areas, and other relevant information.
4. Applicant must submit a site plan showing all available parking, driveways, lighting, and location of trash containers.
5. Applicant must submit a Menu or description of food to be served and the manner in which such food shall be served.
6. Applicant must submit a letter regarding any lease agreement (if applicable).

The applicant is required to be present at a meeting of the Board of Selectmen when they consider the application for approval.

The license is subject to revocation for cause.
