### **1. Overview**

The Town of Carlisle, 66 Westford St, Carlisle, MA 01741, (the “Town”), seeks quotes from qualified firms for purchasing firearms for its police department. ### **2. Scope of Services**

Glock Model 45 Gen 5 MOS5 9mm

- Quantity = 22
- Direct mount Trijicon RM06 3.25moa red dot sight installed
- Ameriglo non-tritium black fixed sights
- 5.5 lb trigger
- Three 17 round magazines included.

Optional Trade-In Credit

The town has the following pistols to trade-in. The Town will consider the total price of the bid to include the trade in value, but reserves the right to purchase the pistols from the lowest bidder without considering the trade in value. Please provide a purchase price with trade in and without trade in values.

- 1.) Glock 22 .40 caliber pistols (24 total)
- 2.) Glock 27 .40 caliber pistols (11 total)

### **3. Term of Contract and Time for Performance:**

This Contract shall be substantially complete by the Contractor on or before June 1, 2023, unless extended pursuant to a provision for extension contained in the Contract Documents at the sole discretion of the Town, and not subject to assent by the Contractor, and subject to the availability and appropriation of funds.
